### High Level Overview of the Meeting:

- The Open Government Secretariat, in partnership with the Data Foundation and Open Gov Hub, hosted a panel discussion and lightning talks focused on open government data on April 25, 2024. The event featured 20 speakers, including 3 panelists, 1 moderator, and 16 lightning talk presenters (8 in-person and 8 virtual), who shared their insights and experiences on various aspects of open data.
- The key themes that emerged from the discussions centered around the importance of open data in fostering public trust, improving customer experience, and driving innovation. Speakers emphasized the need for more accessible, understandable, and consumable data through the use of APIs, data modeling processes, and standardized schemas. They also highlighted the challenges of decentralized data systems and the importance of interoperability through open standards. The impact of emerging technologies, such as AI, on the demand for government data and the need for updated executive guidance was also discussed.
- Speakers shared examples of how open data advances science, government, and nonprofit initiatives, and stressed the importance of public participation and feedback in shaping open data priorities and improving government services. They called for a shift in perspective, viewing open data as a tool for improvement rather than judgment, and emphasized the significance of agile, iterative projects and process models in the successful implementation of open data initiatives. The event also highlighted the progress made by the current administration in advancing open data and the ongoing efforts to improve data accessibility and usability, as well as upcoming opportunities for public engagement, including the Public Participation and Community Engagement (PPCE) Request for Information, Freedom of Information Act (FOIA) business standards, and the nomination process for the Open Government Federal Advisory Committee.

- Taylor Swift (POPVOX Foundation): Discussed the administration's progress on open data and the Department of Commerce's RFI for Open Government Data Assets.

- Brendan Mapes (Public Policy Lab): Shared insights from the PPLUS65 project, which aims to improve Medicare and Medicaid services for older adults through qualitative data.
- Kate Nicholson (BetaNYC): Highlighted the organization's open data literacy programs and the growth of their open data community.
- Ryan Wold (General Services Administration): Discussed the importance of open data in fostering trust in public services and the need for better process models.
- Marc Joffe (XPLUS): Advocated for the implementation of machine-readable grant data standards by OMB and GSA.
