The Open Government Partnership (OGP) is a multilateral initiative aimed at securing commitments from national and sub-national governments to promote open government, combat corruption, and improve governance.



What We Do

The GSA Open Government Secretariat serves three primary roles:

- Nation Action Plan (NAP) 5 Implementation: Coordinate with federal partners to track and report progress on NAP commitments.
- Nation Action Plan (NAP) 6 Development: In coordination with White House OSTP, Department of State, and USAID, co-create the 6th US Open Government NAP with Civil Society Organizations through an open and transparent process and which advances the ideals of a more inclusive, responsive, and accountable Government.
- Stakeholder Engagement: Coordinate with federal government and public stakeholders groups:
 - Federal Stakeholder Engagement
 - Public Stakeholder Engagement
 - Host & Maintain a <u>public website</u>

Commitment Update Process


NAP 5 Implementation

The U.S. 5th Open Government National Action Plan was released by the White House in December 2022, and its 36 commitments and 70 sub-commitments are updated every 6 months.




(Above) Breakdown of the 36 commitments across the five NAP 5 themes

Progress is assessed at the commitment and sub-commitment level, as individual commitments are independent of one another and often have different agency leads for their respective sub-commitments.





Federal Advisory Committee

Stakeholder Engagement

Purpose:

- The Open Government Federal Advisory Committee (OG FAC) will advise GSA in its endeavor to increase the public's access to data, to better advance equity, engage the public in the regulatory process, make government records more accessible, and improve the delivery of government services and benefits through expert advice.
- The OG FAC will serve as an advisory body to GSA on GSA Open Government initiatives including GSA's creation, implementation and monitoring of U.S. Open Government National Action Plans (NAPs) and commitment themes and will advise GSA's Administrator on emerging open government issues, challenges, and opportunities to support GSA's Open Government Secretariat.

Process:

- Notice of Intent To Establish a Federal Advisory Committee and Call for Nominations was published in the <u>Federal Register</u> on April 26, 2024.
- Held a public virtual <u>Q&A session</u> on May 10, 2024
- The window to submit member nominations closed on May 28, 2024
- The Notice of Establishment was posted to the <u>Federal Register</u> on June 28, 2024
- We are in the process of reviewing and vetting potential committee members
- We hope to have our first meeting in early FY 2025


