What is GSA's DEIA Plan?

GSA's DEIA plan is a set of public commitments to advance diversity, equity, inclusion, and accessibility through our mission delivery. This plan responds to an ongoing federal initiative directing agencies to take concrete steps to address systemic challenges facing underserved communities. The GSA Office of Personal Property Management's focus for DEIA is our Federal Surplus Personal Property Donation Program recipients.

What is the Federal Surplus Personal Property Donation Program?

The Federal Surplus Personal Property Donation Program – aka the Surplus Donation Program – enables certain non-federal organizations such as state and local agencies and non-profit organizations to obtain surplus property from the federal government. The program ensures that unneeded government assets continue to benefit the public in communities across the country. The goal of the GSA Office of Personal Property Management is to ensure diversity, equity, inclusion, and accessibility in the program by raising awareness, reducing barriers, and ensuring equal access for underserved communities.

Who is Eligible to Participate?

- ❖ Public agencies
- ❖ Non-profit educational institutions (schools, HBCUs, libraries, etc.)
- ❖ Public health agencies
- ❖ SBA 8(a) or Veteran-Owned Small Businesses (VOSBs)
- ❖ Public airports
- ❖ Educational agencies of special interest to the armed services
- ❖ Veterans Service Organizations (VSOs)
- ❖ And other qualified entities

How Can You Apply to the Program?

Contact your local State Agency for Surplus Property (SASP). SASPs are state-run organizations that administer the federal program for the donation of federal surplus property to public, tax-supported entities and to eligible private, non-profit tax-exempt organizations. SASPs are responsible for determining eligibility of the applicants in their state. To get started, contact your local SASP via www.nasasp.org/findmystate today!

Success Stories

- ❖ A Furniture For Schools (FFS) event resulted in 117 pieces of furniture valued at \$36,944 being donated to three schools.



- ❖ A King Air N914JA plane with an original acquisition cost of \$1.5 million was donated to Lake Area Technical College in Watertown, South Dakota, for use in its Aviation Maintenance Technician and Professional Fixed-Wing Pilot student programs.



- ❖ In collaboration with the GSA Personal Property and the Surplus and Donation Program, the Maryland Department of General Services hosted a diaper-donation event that donated over 1.1 million diapers, approximately 500,000 baby wipes, and two pallets of feminine-hygiene products with an original acquisition cost of \$154,853.34 to over 40 Maryland non-profits, local agencies, and churches.
