THIS AGREEMENT, made and entered into this date by and between Procacci Parcel F, LLC

whose address is 925 South Federal Highway, Suite 400, Boca Raton, FL 33432-6145

hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:  
WHEREAS, the parties hereto agree to supplement the above Lease.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective October 1, 2011, as follows:

This Supplemental Lease Agreement (SLA) No. 3 has been prepared to issue acceptance and Notice to Proceed (NTP) of the Lessor's proposal dated 9/28/11 for provision and installation of a projection screen by reference in the amount of \$5,030.00, at Building 3, 11232 NE 20<sup>th</sup> Street, Miami, FL 33172-1862. \$184,464.14.11 for NTP in SLAs 1 and 2 plus the \$5,030.00 will be paid in a lump sum as stated above totaling \$189,494.11.

A lump sum payment will be due only for items referenced in SLAs 1, 2 and 3.

The Lessor will be issued a lump sum payment in the amount of \$5,030.00 (NTP SLA3) and \$184,464.14 (NTP in SLA1 and SLA2) upon completion, inspection and acceptance of the Scope of Work by the Government. Payment is predicated on receipt of this signed SLA and a certified invoice at the time of work completion. All invoices shall be sent to: U. S. General Services Administration, Finance Division – 7BCP, 819 Taylor Street, Fort Worth, TX 76102-0181 or [www.finance.gsa.gov](http://www.finance.gsa.gov).

Payment will be made electronically through the finance website. The Lessor is responsible for visiting this website and applying for a login and password. After acceptance by the Government the Lessor shall follow the instructions posted on the website to submit their invoice electronically. 

The Lessor hereby waives restoration as a result of all improvements.


