WHEREAS, the parties hereto desire to amend the above Lease to order tenant improvements which exceed the tenant improvement allowance.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective upon execution by the Government as follows:

The purpose of this Supplemental Lease Agreement (SLA) 02 is to add paragraph 19 to incorporate the actual Tel/Data cost credit and change order #1 into the lease contract.

Paragraph 19 is added to the lease contract as set forth below.




"19. The Lessor shall provide and install alterations in consideration of a lump sum payment totaling \$249,739.26 to be paid upon receipt of an original invoice after completion, inspection and acceptance of the change orders by the Contracting Officer.

Actual Tel/Data \$78,061.83 approved via email dated 5/18/2010. Award is based upon Agency review/approval and confirmation of the bid submitted by Volt to meet the SOW prepared by the Agency. Allowance previously included in the Budget Cost Summary for Division 16 per SLA1 \$79,300.00. Credit reconciliation amount owed to the Government total \$1,238.17. See attached documents hereby made a part of the lease contract.

Change Order #1 for [REDACTED] See attached documents hereby made a part of the lease contract.

All other terms and conditions remain in full force and effect.
