The amount of [REDACTED] is hereby approved to remove the currently specified [REDACTED] and add [REDACTED] in its place per Agency request, and to add an exterior sign 44" by 82" in dimension to the exterior of the building.

Lessor hereby acknowledges that under no circumstances, does this authorize the expenditure of funds beyond the amount above. Any additional expenditures made by the Lessor but not first authorized by a GSA Contracting Officer will be made at Lessor's expense.

All Tenant Improvements will be completed by Lessor on or before September 16, 2011. *substantially*
