WHEREAS, the parties hereto desire to amend the above Lease.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective upon Government execution, as follows:

1. This serves as the official approval for change order number two (2) and Change order three (3) in the amount not to exceed \$10,585.04. This amount shall include all materials, labor, and overhead, as described further in Lessor's change order proposals, to complete the work to the Government's satisfaction. Upon completion, inspection, and approval of the work by the Government, the Lessor shall be paid via a one-time lump sum payment in the amount of \$10,495.07 with the remaining amount of \$89.97 to be amortized into the rent. The proposals for change order two (2) and (3) are hereby attached and made a part of the lease. Change order two (2) and three (3) consists of the following:
