


<p>This agreement made and entered into this date by and between Indy Fedreau Company LLC</p> <p>whose address is: 27500 Detroit Road, Suite 300, Westlake, Ohio 44145-5913</p> <p>hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereafter called the Government:</p> <p>WHEREAS, the parties hereto desire to amend the above Lease.</p> <p>The purpose of this Supplemental Lease Agreement (SLA) No. 4 to lease LIN18064, is to amend the lease as stated below.</p> <p>NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective September 19, 2011 and <u>upon signing by both parties</u>, as follows:</p> <p>This SLA #4 is issued to incorporate the 122 change orders that were executed during the construction of the IPOB. The change order request log is attached as exhibit A (4 pages). The log describes and accounts for all 122 requested change orders and the final POR reconciliation. The final accounting of the change orders and reconciliation resulted in a credit due the Government in the amount of \$186,266.41</p> <p>2. The \$186,266.41 credit will remain for the Government's use until reduced to \$0 or the lease term expires. Credit usage will be tracked via excel spread sheet. When fully spent an SLA will be issued to document the credit being reduced to \$0.</p> <p>3. C.O. #35- the Government received a credit for removing the wall covering from the IPOB. Attached as exhibit B (8 pages) is a table and building drawings which identify the areas in which the wall covering was removed. As part of this credit the Government agreed these areas will not receive paint per the SFO.
