



THIS AGREEMENT, made and entered into this date by and between DRA/CLP Research Park Plaza Austin, LP whose address is: 2101 6 th Avenue N, Suite 750 Birmingham, AL 36203-2775 hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereafter called the Government: WHEREAS, the parties hereto desire to amend the above Lease. NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective upon full execution of this agreement, by both parties, as follows: The purpose of this Supplemental Lease Agreement (SLA) 6 is to provide for alterations to the above named lease space. 1. The Lessor shall provide space alterations in consideration of a one time lump sum payment not to exceed \$37,713.53 at 12301 Research Blvd, Suites 270, 200, 180, and 160,, Austin, TX 78759-2302. Space alterations shall be provided in accordance with scope of work attached as Exhibit A. The scope of work (Exhibit A) is hereby incorporated into the lease. 2. Lessor hereby waives all rights to restoration pertaining to these alterations. 3. Full execution of this agreement will serve as the Government's Notice To Proceed. 4. Change orders must be approved by the Contracting Officer. 5. Payment will be made upon completion of the work by the Lessor and acceptance by the Government. 6. In order to receive payment, the Lessor should create and include a unique invoice number on the invoice submitted for payment. The invoice should have the Lessor's name and lease number cited exactly how it is stated on the lease contract. The invoice should include the PDN number PS0020352 . Lessor should submit invoices electronically on the GSA Finance Website at www.finance.gsa.gov (instructions for submitting invoices are found on the website).
