**THIS AMENDMENT** is made and entered into between MT Acquisitions, LLC whose address is: 10 West Market Street, Suite 1200, Indianapolis, IN 46204-2954 hereinafter called the Lessor, and the **UNITED STATES OF AMERICA**, hereinafter called the Government.

**WHEREAS**, the parties hereto desire to amend the above Lease providing for a lump sum payment.

NOW THEREFORE, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended, effective February 19, 2013 as follows:

A. Paragraph 7.07 is added to this lease as follows:

"7.07. The total cost to install 2 meters to meter electric use for HVAC in the computer rooms is [REDACTED]. Per a letter agreement dated November 15, 2012 and signed by both parties on November 16, 2012, the Government agrees to pay the Lessor a one time lump sum payment in the amount of [REDACTED] for half the cost of the meters.
