Discussion

These comments due dates are clearly incorrect and likely typographical errors, as they list the due dates far into the future (the years 2099 through 2018).

Intention to Appeal

If my request for correction of information under Section 515 of Public Law 106-554 is denied, I will appeal the decision under the administrative appeal provisions. Thank you for considering this information.

Substitute Information:

The corrected information should reflect accurate dates for comments due.

These corrections ensure consistency with historical records and the expected timeframes for public comment periods.

Reasons for Correction:

The incorrect information should be corrected because:

1. The current dates listed are absurd (2099) and undermine the credibility and reliability of the information on regulations.gov.

2. Accurate dates are crucial for transparency and public participation in the rulemaking process.
3. Correcting these errors will help prevent confusion and ensure that stakeholders can provide timely feedback on regulatory matters.
4. These regulatory items show up erroneously in every search for dockets still open for comment.
5. The help desk at Regulations.gov outright refused to address or respond to the problem, saying it wasn't their responsibility.

Supporting documentary evidence includes:

- Historical records of standard comment periods for similar petitions.
- Comparable data from other exemption/rulemaking petitions from the same timeframe.

Conclusion:

I was appalled by the refusal of the Regulations.gov team to correct the errors. I respectfully request that the GSA review this request and make the necessary corrections to the information as outlined above. Thank you for your attention to this matter.
