

Subject: Special Item Numbers (SINs) 54151HACS and 517312 Subgroup Instructions

Dear MAS Contractors Holding SINs 54151HACS and 517312,

As a follow-up to the February 2, 2021 email related to SIN Subgroups, this notification outlines the actions contractors must take to select SIN Subgroups for SINs **54151HACS** and **517312**. Below are instructions for selecting SIN Subgroups in your eBuy profile page starting on **Tuesday, February 9th**.

Contractor selection of a SIN Subgroup MUST correspond to the awarded offerings under that specific SIN on their MAS contract. All contractor selections will be monitored by GSA for compliance and action will be taken against your contract if you select Subgroups that have not been awarded under your contract.

How to select SIN Subgroups:

- 1 - Login to eBuy
- 2 - From the top menu, select "Profile"
- 3 - Click "Modify Subgroups"
- 4 - Select the applicable subgroups according to the instructions

SIN Subgroups were created to give buyers the ability to clearly identify the smaller subsets of contractors that offer specific products and services under a broad MAS SIN or identify where specific certification requirements are met for technical products, services, or solutions. Subgroups give further clarity or specificity of contractor offerings under a particular SIN. They do NOT expand or limit the scope of awarded contract offerings.

The following SINs require certification of Subgroups by a Contracting Officer (CO) and may only be selected after the appropriate contract action is complete. A contractor cannot self-certify without evidence that such Subgroups were accepted by the CO. For specific SIN requirements, please view the SIN Descriptions in the [MAS Solicitation](#).

GSA will be performing a quality assurance check of your SIN Subgroup selections against your MAS contract. **Misrepresentation of your awarded offerings under MAS may result in removal of your catalog from GSA eTools.**
