WHEREAS, the parties hereto desire to amend the above Lease to formally accept phase one change orders.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective upon execution by the Government, as follows:

Paragraphs 32 is hereby added to the Lease:

"32. Phase 1 Tenant Improvement Change Orders

In separate correspondence, the Government authorized the tenant improvement changes described in hereinafter. The total cost for these Tenant Improvement changes is for the firm amount of \$15,900. This brings the total Tenant Improvements to \$21,815,313.00. \$11,422,056.00 of the total amount of \$21,819,033.00 will be amortized into the rent as set forth in paragraph 15 of the SF-2. The Government hereby orders the balance of \$10,393,257.00.
