THIS AGREEMENT made and entered into this date by and between Speedy Tang, LLC

whose address is: 944 Market Street, Suite 800, San Francisco, California 94102

hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WHEREAS, the parties hereto desire to amend the above lease to authorize Tenant Improvement Change Orders.

THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended as follows:

Paragraph 31 is hereby deleted and the following substituted therefore.

"31. Pursuant to paragraph 17, the new total cost for Tenant Improvements in the amount of ~~\$377,660.07~~ ^{\$377,660.73} (as a result of Change Order #1 in the amount of \$11,213.73) exceeds the tenant improvement allowance by \$124,802.10. Upon completion, inspection, and acceptance of the space, the Government shall reimburse the Lessor in a lump sum payment in the amount of ~~\$124,802.10~~ ^{\$124,802.10} pursuant to Paragraph 32, herein. The Lessor hereby waives restoration as a result of all improvements."

Paragraph 33 is hereby added.

"33. NOTICE TO PROCEED – Change Order #1

Notice to Proceed is hereby issued for the construction of Tenant Improvements, as identified in the attached Sheets 2 through 5, at a total cost not to exceed \$11,213.73, inclusive of all management and architectural fees."
