WHEREAS, the parties hereto desire to amend the above Lease to issue a Notice to Proceed for Change Order #6, #8, #9, #10 and # 13 for a total amount of \$3,218.66.

NOW THEREFORE, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended, effective upon execution of the Government as follows:

I. As recently negotiated, the Government approves the change orders as described below. The anticipated date of completion of all the tenant improvements shall remain the same.

- Change Order #6 – Provide and install backing for [REDACTED] at [REDACTED] - [REDACTED]
- Change Order #7 – Lessor Cost
- Change Order #8 – Relocate existing utilities to accommodate floor plan and clear ductwork - [REDACTED]
- Change Order #9 – Furnish and install open casework laptop and cell phone storage at existing rough openings in lieu of prefabricated lockers. Laptop storage to include plug strip and flat shelving along with added power for laptop charging per RFI 9 – [REDACTED] Credit
- Change Order #10 – Additional design services (Architect [REDACTED], Structural Engineer [REDACTED]) for revised security design criteria - [REDACTED]
- Change Order #11 & 12 – Lessor Cost
- Change Order #13 – Wrap and ground existing gas line at room 14 as required by security - \$669.93

If the invoice is not submitted on company letterhead, the person(s) with whom the Lease contract is made must sign it.

- III. The Lessor hereby waives restoration as a result of all improvements. Unless the Government has removed such items from the premises, the Lessor shall repair and maintain such items provided by the Lessor in accordance with this Lease Agreement GS-09B-02973. If, after the lease term or any extensions, or succeeding lease term, the Government elects to abandon any items in place, title shall pass to the Lessor.

All other terms and conditions of the lease shall remain in force and effect.
