WHEREAS, the parties hereto desire to amend the above Lease to issue a Notice to Proceed for Change Order #21, #22, #25, #26 and #27 for a total amount of \$33,789.82.

NOW THEREFORE, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended, effective upon execution of the Government as follows:

I. As recently negotiated, the Government approves the change orders as described below. The anticipated date of completion of all the tenant improvements shall remain the same.

- Change Order #21 – Provide and install 16 gauge sheet metal at storefront door and sidelight. Install 5/8" fire treated plywood at storefront glazing above door. - [REDACTED]
- Change Order #22 – Replace glazing panels with spandrel glass at two locations - [REDACTED]
- Change Order #25 – Install 14 gauge galvanized sheet metal over TVM and existing gypcrete in room(s) 6 and 14. [REDACTED]
- Change Order #26 – Add one ground bar and one L-5 receptacle at room 12. At room 4A and 4 add two circuits per room: - [REDACTED]
- Change Order #27 – Provide and install a 1-1/4" duct with pull cord. - [REDACTED]
 Authorize reimbursable A/E fees - [REDACTED]

If the invoice is not submitted on company letterhead, the person(s) with whom the Lease contract is made must sign it.

- III. The Lessor hereby waives restoration as a result of all improvements. Unless the Government has removed such items from the premises, the Lessor shall repair and maintain such items provided by the Lessor in accordance with this Lease Agreement GS-09B-02973. If, after the lease term or any extensions, or succeeding lease term, the Government elects to abandon any items in place, title shall pass to the Lessor.

All other terms and conditions of the lease shall remain in force and effect.
