1). This Lease Amendment (LA) No. 1 is your Notice to Proceed (NTP) to furnish and install Tenant Improvements as required and outlined in Lease No. LFL62279. The total cost for the Tenant Improvement is \$2,099,982.30 pursuant to attached Exhibit "A". Of the \$2,099,982.30 only \$748,173.00 has been amortized into the rent at 6.0% for 120 (One hundred twenty) months. The Government hereby orders the balance of \$1,351,809.30.

2). Upon completion, inspection and acceptance of the space, the Government shall reimburse the Lessor in a lump sum payment in the amount of \$\$1,351,809.30, upon receipt of an original invoice after completion, inspection and acceptance of the space by the Contracting Officer.
