**THIS AMENDMENT** is made and entered into between Duke Realty Limited Partnership

hereinafter called the Lessor, and the **UNITED STATES OF AMERICA**, hereinafter called the Government:

**WHEREAS**, the parties hereto desire to amend the above Lease.

**NOW THEREFORE**, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective January 2, 2014, as follows:

- I. Upon full execution of Lease Amendment #5, the Government hereby issues Notice to Proceed for additional Tenant Improvements (TI) of Change Order #2. The Lessor shall provide all the materials, labor, and services required to provide for the completion of the Tenant Improvements depicted and according to the Exhibit "A". The total cost for this change order is not to exceed \$31,279.03.
- II. Per paragraph 1.09 of the lease, the Government elects to make a lump sum payment for the entire Tenant Improvement work of the amount of \$621,667.29 (\$590,388.26 + \$31,279.03).

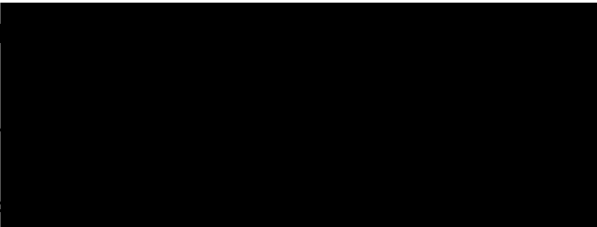
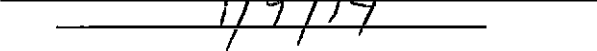
