WHEREAS, the parties hereto desire to amend the above Lease:

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective July 1, 2013 as follows:

The Government conditionally accepts the space pending completion of the Tenant Improvements (TI) and Building Specific Security (BSS).

Paragraph 1.01 of the Lease is hereby deleted in its entirety and replaced to read as follows:


1). A total of 9,193 rentable square feet (RSF) of office and related space, which yields 7,994 ANSI/BOMA Office Area square feet (USF) of space located on the 7th floor and known as **Suite 7 West**, at **701 San Marco Blvd, Jacksonville, Florida 32207-9998** (The Premises), to be used for such purposes as determined by the General Services Administration. Included in the rental consideration at no additional cost to the Government are Fifteen (15) surface parking spaces, Ten (10) regular and Five (5) large spaces.

This Lease Amendment contains 2 page.

All other terms and conditions of the lease shall remain in force and effect.



2). The Government shall pay the Lessor monthly in arrears in accordance with the following table:

Except as modified in this Agreement, all terms and conditions of the Lease shall remain in full force and effect, and in the event that any of the terms and conditions of the Agreement conflict with any terms and conditions of the Lease or any previous supplemental lease agreements, the terms and conditions of this Agreement shall control and govern.
