

The Lessor shall construct all Tenant Improvements in accordance with Exhibit H, section 4 of the Lease, and all terms and conditions of the Lease package. Upon completion, inspection and acceptance of the space, the Government shall reimburse the Lessor in a lump sum payment in the amount of \$46,691.53, pursuant to Paragraph 1.19, herein. The Lessor hereby waives restoration as a result of all improvements.
