[2] Lump Sum Payment For Lease Amendment No. 14 For Change Order No. 11

Upon the completion, inspection, and acceptance of all work items by the Lease Contracting Officer (LCO) or his or her designated representative, the Government shall reimburse the Lessor a Lump Sum Payment in the amount of [REDACTED] for Change Order No. 11.

Upon completion and acceptance of Change Order identified herein, the Lessor shall submit for Lump Sum Payment of [REDACTED] by following these instructions:

1. Create and include a unique invoice number on the invoice submitted for payment.
2. Vendor's name and address must match the payee on the Government's lease document.
3. Please cite **PS Number PS0039887** on your invoice and submit the invoice directly to the General Services Administration, Greater Southwest Finance Center with a copy to the Leasing Contracting Officer. Invoices submitted to Finance without the PS number are immediately returned to the vendor or Lessor.

This NTP only approves the amount of [REDACTED] for this Change Order No. 11. Any additional expenditure must be approved by the LCO in writing.

Title to items for which the Government makes a "Lump Sum" payment shall vest in the Government. These items can be removed in a commercially reasonable fashion by the Government at any time. The Lessor waives any restoration in connection with these items. Unless the Government has removed the items from the premises, the Lessor shall remain responsible for maintenance and repair of all items provided by the Lessor under this lease. If, after the lease term, any extensions or succeeding lease term, the Government elects to abandon any items in place, title shall pass to the Lessor. This paragraph shall also apply throughout the term of the lease to any work requested by the Government after occupancy.
