THIS AGREEMENT, made and entered into this date by and between VERMILLION PROPERTIES, L.L.C.

hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WHEREAS, the parties hereto desire to amend the above Lease to order tenant improvements which exceed the tenant improvement allowance.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective upon execution by the Government, as follows:



- I. This Supplemental Lease Agreement (SLA) is your Notice to Proceed to furnish and install tenant improvements as required and outlined in SFO No. 8LA2110. The total cost for the tenant improvements is \$695,503.05. Of the \$695,503.05, only \$405,217.05 has been amortized into the rent at 5.50% for 120 months. The Government hereby orders the balance of \$290,286.00.
- II. Upon completion, inspection, and acceptance of the space, the Government shall reimburse the Lessor in a lump sum payment in the amount of \$290,286.00, upon receipt of an original invoice after completion, inspection, and acceptance of the space by the Contracting Officer.


If the invoice is not submitted on company letterhead, the person(s) with whom the Lease contract is made must sign it.
