THIS AGREEMENT, made and entered into this date by and between

hereinafter called the Lessor, and the **UNITED STATES OF AMERICA**, hereinafter called the Government:

WHEREAS, the parties hereto desire to amend the above Lease: To order tenant improvements which exceed the tenant improvement allowance.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective upon full execution by the Government as follows:

- 1). This Lease Amendment (LA) No. 2 is your Notice to Proceed to furnish and install Change order #1 as part of the Tenant Improvements. The total cost for the Tenant Improvement was [REDACTED] pursuant to lease amendment #1. The cost of Change order #1 is [REDACTED]. Therefore the total cost for the Tenant Improvement increased to **\$459,729.92** [REDACTED] + [REDACTED] = **\$459,729.92**). Of the **\$459,729.92** only **\$159,004.30** has been amortized into the rent at 7.75% for 120 (One hundred twenty) months. The Government hereby orders the balance of **\$300,725.62** (**\$459,729.92 - \$159,004.30 = \$300,72.62**).
- 2). Upon completion, inspection and acceptance of the space, the Government shall reimburse the Lessor in a lump sum payment in the amount of **\$300,725.62**, upon receipt of an original invoice after completion, inspection and acceptance of the space by the Contracting Officer.

This Lease Amendment contains 2 pages, and EXHIBIT "A" contains 2 pages.

All other terms and conditions of the lease shall remain in force and effect.
