- 1.) Upon this Lease Amendment (LA) being fully executed and delivered, the Lessor shall consider this a Notice to Proceed with the construction of the Tenant Improvements (TI). The anticipated date of completion of all the Tenant Improvements is on or before 60 working days from the date of full execution and delivery of this Lease Amendment.
- 2.) The Government and the Lessor have agreed that the total cost of the TIs is \$626,716.51, as shown on the Tenant Improvement Cost Summary (TICS) attached as Exhibit A to this Lease Amendment No. 2. The TI cost includes all of the Lessor's fees for general and administrative costs, profit and any and all other fees associated with the completion of the TI by the anticipated date of completion.
- 3.) The Government shall pay for a portion of the total TI Cost by amortizing \$300,157.81 over the first ten (10) years of the term, monthly in arrears, at an interest rate of 5.75%. All of the remaining balance of \$326,558.70 [\$626,716.51 (Total TI cost) \$300,157.81 (TI amortized) = \$326,558.70] shall be paid by lump-sum.

Upon the completion of the TI and the acceptance thereof by the Government, the rent commencement date and the adjusted rent schedule (if required due to the amount amortized) shall be established by a separate LA. The subsequent LA shall include the term of the scheduled total rent, the annual Shell Rent amount, the annual Operating Cost amount, and the annual amortized TI and Building Specific Amortized Capital cost (if any).

Once the exact amount of the lump-sum payment has been determined by both parties and the LA is fully executed by the Government and the Lessor, the Lessor may then submit for the lump-sum-payment. The Lessor agrees that the invoice shall be printed on the same letterhead as the named on this lease, shall include the Lease number, building address, and a price and quantity of the items delivered. **The invoice shall reference the number PS0027955** and shall be sent electronically to the GSA Finance Website at https://www.finance.gsa.gov.
