WHEREAS, the parties hereto desire to amend the above Lease

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective April 30, 2014, as follows:

- I. Upon full execution of Lease Amendment #2, the Government hereby issues Notice to Proceed for additional Tenant Improvements (TI) of Change Orders #1 & #3. The Lessor shall provide all the materials, labor, and services required to provide for the completion of the Tenant Improvements depicted and according to the Exhibit "A". The total cost for the change order is not to exceed [REDACTED]. The tenant improvements totaled [REDACTED] will be amortized in the rent at a rate of 7% over ten (10) years period.
