NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective MARCH 31, 1993

- Paragraphs 1, 2 and 3 of the Lease, Standard Form 2, are amended by deleting the existing texts in their entireties and substituting, in lieu thereof the following:
- "1. The Lessor hereby leases to the Government the following described premises: 264,753 net usable square feet of office and related space being further defined as 4,838 net usable square feet on the first floor and all the usable space in the remainder of the building floors 2 through 11 and the penthouse area of the City Crescent Office Building, Howard and Baltimore Streets, Baltimore, Maryland, (including 89 indoor parking spaces at the location) to be used for such purposes as may be determined by the General Services Administration."
- TO HAVE AND TO HOLD the said premises with their appurtenances for the term beginning on March 31, 1993 through March 30, 2003, subject to termination and renewal rights as may be hereinafter set forth."
- "3. The Government shall pay the Lessor annual rent of \$6,287,883.75 at the rate of \$523,990.31 per month in arrears. Rent for a lessor shall be prorated. Rent checks shall be made payable to: City Crescent Limited Partnership
