WITNESSETH: The parties hereto for the considerations hereinafter mentioned, covenant and agree as follows:

1. The Lessor hereby leases to the Government the following described premises:

A total of 11,618 Rentable Square Feet (RSF) of office and related space, which yields 10,200 ANSI/BOMA Office Area square feet (USF) of space located on the 4th floor at 28 Allegheny Avenue, Towson, MD 21204-3909 to be used for such purposes as determined by the General Services Administration. As sole tenant on the 4th floor, the Government enjoys beneficial use of 1,376 RSF (1,208 USF) at no additional cost. Also included in the rent, at no additional cost to the Government, are forty-five (45) structured and reserved parking spaces on the 5th level parking deck for the exclusive use of Government fleet vehicles, employees, and visitors. Signage will direct visitors to the location.

- 2. TO HAVE AND TO HOLD the said premises with their appurtenances for the term beginning on (see Rider to Lease, Paragraph 12) and continuing through (see Rider to Lease, Paragraph 12), subject to termination and renewal rights as may be hereinafter set forth.
- 3. The Government shall pay the Lessor annual rent of (see Rider to Lease, Paragraph 13).

Rent for a lesser period shall be prorated. Rent checks shall be made payable to:

4. The Government may terminate this lease in whole or in part at any time on or after the fifth (5th) full year of occupancy by giving at least ninety (90) days' notice in writing to the Lessor and no rental shall accrue after the effective date of termination.
