WHEREAS, the parties hereto desire to amend the above Lease to **issue notice to proceed for Tenant Improvements**.



NOW THEREFORE, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended, effective upon execution by the Government, as follows:

- A. In separate correspondence dated November 12, 2014, the Government has issued a Notice to Proceed for Tenant Improvements in the amount of \$69,750.00. The total costs amortized into the rental rate for tenant improvements are \$47,220.38. The remaining portion of the Tenant Improvements will be paid via a one-time lump sum payment in the amount of \$22,529.62.
- B. The Government shall reimburse the Lessor in a lump sum payment in the amount of \$22,529.62, upon receipt of an original invoice after completion, inspection, and acceptance of the space by the Contracting Officer.




