This Supplemental Lease Agreement (SLA) No. 2 is issued to document the agreed total amortized and unamortized tenant improvements pursuant to the Design Intent Drawings and Special Requirements, attached as part of this lease, Accordingly, Paragraph 25 is added to this lease as follows:

25. The total Tenant Improvement cost to produce the space pursuant to the Design Intent Drawings and Special Requirements is \$146,051 of which \$159,183 will be amortized into rent payment over 60 months at 6.5%. The Government agrees to pay the Lesson a one time lump sum payment in the amount of \$26,868 for initial tenant improvement construction costs that will not be amortized in the monthly rental payments.

The Special Requirements and government Design Intent drawings will be an attachement to this SLA #2 showing the source from which the agreed tenant improvements were negotiated from.

Initial Tenant Improvement Overage \$26,868

The lessor waives any right to future payment for the initial construction costs except for the 26.868 that will be amortized in monthly rent as stated in Paragraph 3 of this lease.
