WITNESSETH: The parties hereto for the consideration hereinafter mentioned, covenant and agree as follows:

1. The Lessor hereby leases to the Government the following described premises:

316 8th Avenue, Second Floor - South Side, International Falls, MN, Office space consisting of 1,000 ABOA square feet (1,150 rentable) and two (2) reserved parking spaces.

- TO HAVE AND TO HOLD the said premises with their appurtenances for a ten (10) year term, five (5) years
 firm term beginning the date the leasehold improvements constructed by the Lessor are substantially completed
 and accepted by the Government, subject to termination and renewal rights, if any, as may be hereinafter set forth.
 The date of substantial completion is no later than March 1, 2012.
- 3. The Government shall pay the Lessor annual rent of

Years 1-5: \$57,500.00, at the rate of \$4,791.67 per month in arrears based on a rate of \$57.50 per ABOA Usable Square Foot (\$50.00 per rentable square foot).

Years 6-10: \$35,638.50, at the rate of \$2,969.88 per month in arrears based on a rate of \$35.64 per ABOA Usable Square foot (\$30.99 per rentable square foot).

The Government shall pay the Lessor annual rent as follows:

The Government may terminate this lease at any time on or after the FIFTH YEAR or March 1, 2017 of the lease by giving at least 90 days notice in writing to the Lessor and no rental shall accrue after the effective date of termination. Said notice shall be computed commencing with the day after the date of mailing.
- 5. This lease may be renewed at the option of the Government, for the following terms and at the following rentals:

 - Lessor will be held to the International Falls, MN local fire code and regulations. Occupancy.
 - Permit will be inspected after acceptance of space and review by fire department to provide new Occupancy Permit to the build.
 - Lessor will not be held to ABBAS regulations provided with in SFO paragraphs.
 - Engineering and Design Fees have not been made a part of the shell rental rate and will be paid via the Tenant Improvement allocation provided by lessor and amortized.
 - The building will not require sprinklers to be provided as this is a two story residential office space that does not require sprinklers.
 - -Shell rental rate includes back-up power generator, MDI security, and 20' awning over entry way.

- The date of this lease is the date this contract was formed as a result of the Government's acceptance of the Lessor's Best and Final Offer dated July 19, 2011, submitted by the Lessor under SFO No. GS-05B-18465. This lease reflects the terms and conditions of the accepted Best and Final Offer.
- 10. The lease commencement date of March 1, 2012 in Paragraph 2 of the Standard Form 2, U.S. Government Lease for Real Property, is the estimated effective date. If the actual date of beneficial occupancy is different from March 1, 2012, then the actual effective date shall be established by a Supplemental Lease Agreement. The lease term will then be in effect for ten (10) years thereafter, computed from the actual effective date. The anniversary date for adjustments shall be adjusted to coincide with any revised actual effective date.
- 11. Lessor shall not construct alter, remove, or add to the lease area without prior notification and approval from the General Services Administration (the Contracting Officer).
- 12. The Lessor will alter the space ready for occupancy no later than March 1, 2012.
- 13. The total net usable square foot area referred to in Paragraph 1 is subject to adjustment but may not be less than the minimum of 1,000 ABOA offered. The Lessor may deliver up to the maximum usable square footage allowable identified in Paragraph 1 of the SFO. Should there be any adjustments in the usable square footage delivered that has been determined through mutual field measurement, the per annum rental referred to above shall be adjusted on the basis of \$57.50 ABOA per square foot per annum for Years 1-5 and \$35.63 ABOA per square foot per year for Years 6-10 0 of the lease. The lease shall be amended by Supplemental Lease Agreement after the actual field measurement to establish the square footage and rental in compliance with the terms of the lease. In the event the actual amount of space exceeds 1,150 ABOA square feet, 1,150 Rentable there will be no additional cost to the Government.
- 14. If the property housing the leased premises is sold or transferred the following information is required before the Government can acknowledge the successor in interest and change the payee for rent or other payments.
 - (I) Evidence of the transfer of title.
 - (II) A letter from successor lessor (transferee) assuming, approving, and adopting the lease and agreeing to be bound by its terms.
 - (III) A letter from prior lessor (transferor) waiving all rights against the United States of America, except unpaid rent through a specified Date, usually the date of ownership transfer.
 - (IV) The IRS tax identification number for the new owner.

Where leased premises are transferred by death of lessor, a copy of the letters of administration where there is no will, showing the lessor(s), is required. Unless an interim court order is received, rents will be accrued and paid to the new owner(s) upon final settlement of the estate.

- 17. For the purpose of computing operating cost adjustments in accordance with SFO GS-05B-18465 paragraph 4.3, the first year's base cost is hereby established as \$13,742.50 per annum or \$13.74 per ABOA square foot, \$11.95 per rentable square foot.
- 18. For the purpose of computing Real Estate Tax adjustments in accordance with Clauses 3.4 and 3.5 of Solicitation for Offers GS-05B-18465 (the "SFO"), it is agreed that the Government occupies 21% of the Building (5,400 RSF) of which the Government shall pay taxes when they exceed the base year of \$1,300 budgeted for taxes per GSA Form 1217, signed June 13, 2011.
- 19. If overtime HVAC is required, there will be no extra charge per hour.
- 20. The Lease Common Area Factor is 1.15 (1,150 rentable square feet divided by 1,000 ABOA square feet).
- 21. In accordance with paragraph 3.2 A and Amendment #1 provided on May 31, 2011, the Lessor shall provide Tenant Improvement funds not to exceed \$57,330.00 total at acceptance of space and supplemental agreement to accept all funds will be amortized at 8.95% over 60 months, the firm term of five (5) years of the ten (10) year lease. All tenant improvement shall be inspected and accepted by a Contracting Officer or authorized representative of the government and documented with supplemental lease agreement at occupancy.
- 22. The Contracting Officer represents the General Services Administration as an agent with the authority to enter into this Lease on behalf of the Government and executes this document in his or her official capacity only, and not as an individual.
- 23. The Lessor shall control the dissemination of Sensitive but Unclassified information contained in the Solicitation for Offers, design standards, space programming documents, construction drawings and any other sources of information relating to the Government occupancy, as established in Lease Attachment #1, "Document Security Form". The Lessor shall issue the Document Security Form, acquire required documentation and verify information prior to disseminating any Sensitive but Classified information. In addition, the Lessor shall maintain a file of Document Security Forms issued and received in conjunction with this project.
- 24. COMMISSION AND COMMISSION CREDIT: In accordance with SFO Paragraph 2.3. Broker Commission and Commission Credit, UGL Services Equis Operations Co. ("Broker") is the authorized real estate broker representing GSA in connection with this lease transaction. The total amount of the Commission is and is earned upon lease execution, payable according to the Commission Agreement signed between the two parties, executed on May 4, 2011. Due to the Commission Credit described in SFO Paragraph 2.3.B, only of the Commission, will be payable to UGL Services Equis Operations Co. with the remaining which is the "Commission Credit", to be credited to the shell rental portion of the annual rental payments due and owing to fully recapture this Commission Credit. The reduction in shell rent shall commence with the first month of the rental payments and continue until the credit has been fully recaptured in equal monthly installments over the shortest time period practicable.
