The total amount of the Commission is and is camed upon Lease execution, payable according to the Commission Agreement signed between the two parties. Only of the Commission will be payable to CBRE. INC with the remaining **statutes**, which is the Commission Credit, to be credited to the shell rental portion of the annual rental payments due and owing to fully recepture this Commission Credit. The reduction in shell rent shall commence with the first month of the rental payments and continue until the credit has been fully recaptured in equal monthly installments over the shortest time possible.

B. Notwithstanding the "Rent and Other Consideration" paragraph of this Lease, the shell rental payments due and owing under this Lease shall be reduced to recepture this Commission Credit. The reduction in shell rent shall commence with the first month of the rental payments and continue as indicated in this schedule for sted Monthly Rent:

The effective date of the termination shall be the day following the expiration of the required notice period or the termination set forth in the notice, whichever is later. No rental shall accrue after the effective date of termination."
