# SECTION 1 THE PREMISES, RENT, AND OTHER TERMS

#### 1.01 THE PREMISES (SIMPLIFIED) (AUG 2011)

# 1.02 EXPRESS APPURTENANT RIGHTS (SIMPLIFIED) (JUN 2012)
