WHEREAS, the parties hereto desire to amend the above Lease: establish lease effective date and provide lump sum payment.		
NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective 1/1/11, as follows:		
A. Paragraph 2 of the Lease (Standard Form 2) is hereby deleted in its entirety and replaced with the following:		
"2. TO HAVE AND TO HOLD the said premises with their appurtenances for the term beginning on <u>January 1, 2011</u> through <u>December 31, 2020</u> , subject to termination and renewal rights as may be hereinafter set forth."		
B. The Lessor agrees to provide, install and maintain the following items (see Attachment A to this SLA # 3) in the amount of \$109,386.00 which is to be paid lump sum upon completion and acceptance.
