hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WITNESSETH: The parties hereto for the consideration hereinafter mentioned, covenant and agree as follows:

1. The Lessor hereby leases to the Government the following described premises:

6,732 Rentable Square Feet yielding 6,057 ANSI/BOMA (ABOA) Office Area square feet and related space located on the fourth (4<sup>th</sup>) floor, at the Station Plaza IV, 22 South Clinton Avenue, Trenton, NJ 08609-1212, together with fourteen (14), structured parking spaces, as depicted on Exhibit A (attached).

to be used for such purposes as determined by the General Services Administration.

- 2. TO HAVE AND TO HOLD the said premises with their appurtenances for the term beginning on See Lease Rider Paragraph 13 through See Lease Rider Paragraph 13, subject to termination and renewal rights as may be hereinafter set forth.
- 3. The Government shall pay the Lessor annual rent of \$ Sec Lease Rider Paragraph 13 at the rate of

- 4. The Government may terminate this lease in whole or in part effective at any time after the fifth (5<sup>th</sup>) full year of occupancy by giving at least ninety (90) days notice in writing to the Lessor and no rental shall accrue after the effective date of termination. Said notice shall be computed conumencing with the day after the date of mailing.
- 5. This lease may be renewed at the option of the Government, for the following terms and at the following rentals:

  One (1) Five (5) year period(s) at the annual rental of \$144,266.76 (\$21.43 per Rentable square foot), plus accrued operating cost escalations, provided notice be given in writing to the Lessor at least ninety (90) days before the end of the original lease term or any renewal term; all other terms and conditions of this lease shall remain the same during any renewal term. Said notice shall be computed commencing with the day after the date of mailing.
  - 6. The Lessor shall furnish to the Government, as part of the rental consideration, the following:
    - A. All services, utilities, maintenance, operations, and other considerations as set forth in this lease.

	B. The Lessor and the Broker have agreed to a cooperating lease commission of of the firm term value of this lease. The total amount of the commission is the Lessor shall pay the Broker no additional commissions associated with this lease transaction. In accordance with the "Broker Commission and Commission Credit" paragraph, the Broker has agreed to forego of the commission that it is entitled to receive in connection with this lease transaction ("Commission Credit"). The Commission Credit is the Lessor agrees to pay the Commission less the Commission Credit to the Broker in accordance with the "Broker Commission and Commission Credit" paragraph in the SFO attached to and forming a part of this lease.

- 9. In no event shall the lessor enter into negotiations concerning the space leased with representatives of Federal agencies other than Contracting Officers and their designated representatives of the General Services Administration.
- 10. The total percentage of space occupied by the Government under the terms of the lease is equal to 7.82791% percent of the computing the Government's pro-rata share of real estate taxes, as defined in the Annual Real Estate Tax Escalation Clause. The percentage of occupancy is derived by dividing the total Government space of 6,732 rentable square feet by the total building space of 86,000 rentable square feet.
- 11. For purposes of determining the base rate for future adjustments to the operating cost, the Government agrees that the base rate of \$47,258.64 per year or \$7.02 per rentable square foot, is acceptable. This figure includes the Government's pro-rata share of operating costs.
- 12. Notwithstanding any other provision of this agreement requiring the Government to give notice to exercise any option contained herein for extension of the lease for additional space in the facility, or for purchase of the facility, the lessor shall notify the Contracting Officer, in writing, at least thirty (30) calendar days and no more than sixty (60) calendar days prior to the time the option must be exercised. In the event the lessor fails to notify the Government, as required by this paragraph, the Government shall have the right to exercise the option at anytime prior to the expiration of the lease. If GSA exercises the option to renew the lease, said rental will be based on the amount of operating cost adjustments accrued up to date of renewal and calculation on the basis of the new adjusted base rate for services and utilities.
- 13. Lessor shall complete the building shell as defined in the lease and complete all alterations, improvements, and repairs required by this lease, and deliver the leased premises ready for occupancy by the Government within ninety (90) working days from the date of notice to proceed with the construction of the tenant improvements. When Lessor has completed all such alterations, improvements, and repairs, Lessor shall promptly notify the Contracting Officer, who shall promptly cause the same to be inspected.

Upon the date of completion of such alterations, improvements, and repairs and inspection and acceptance by the Government, the term of this lease shall commence and shall continue for ten (10) consecutive calendar years. The 3 of 98

Upon acceptance of the leased premises by the Government, the same shall be measured and rental shall be paid, in accordance with Paragraph 4.1 of the lease, "Measurement of Space" and Paragraph 27 General Clauses, GSA Form 3517, "Payment" at the rate of:

In accordance with lease negotiations, the Tenant Improvement rate stated above reflects an interest rate of 6% over a one hundred and twenty (120) month period, which exceeds the firm term of the lease. Should the Government exercise its termination rights, the Government shall have no obligation to pay the Lessor any remaining balance for the Tenant Improvement rent beyond the firm term of the lease.

**Annual Cost of Services:** \$47,258.64 per year or \$ 7.02 per Rentable square foot, <u>plus accrued escalations</u> per Paragraph 4.3, "Operating Costs"

Amortized annual cost for Building Specific Security: \$2,664.49 per year, or \$0.39 per Rentable square foot.

In accordance with lease negotiations, the Amortized annual cost for Building Specific Security stated above reflects an interest rate of 6% over a one hundred and twenty (120) month period, which exceeds the firm term of the lease. Should the Government exercise its termination rights, the Government shall have no obligation to pay the Lessor any remaining balance for the Tenant Improvement rent beyond the firm term of the lease.

In accordance with lease negotiations, the Tenant Improvement rate stated above reflects an interest rate of 6% over a one hundred and twenty (120) month period, which exceeds the firm term of the lease. In accordance with lease negotiations, the Amortized annual cost for Building Specific Security stated above reflects an interest rate of 6% over a one hundred and twenty (120) month period, which exceeds the firm term of the lease. Should the Government exercise its termination rights, the Government shall have no obligation to pay the Lessor any remaining balance for the Tenant Improvement rent beyond the firm term of the lease.

If the Government spends more than the allowance identified above, the Government reserves the right to 1) reduce the Tenant Improvement requirements, 2) pay lump sum for the overage upon completion and

- 14. In accordance with Paragraph 3.4, "GSA Forms and Pricing Information" and Paragraph 5.1, "Tenant Improvements Pricing Requirements" of the Lease, the Lessor's Tenant Improvement Fees are established as follows:
  - 1) General Conditions charged by the Lessor's General Contractor for Tenant Improvements requested by the Government is 0% of Total Subcontractors' costs.
  - 2) General Contractor's fee charged by the Lessor for Tenant Improvements requested by the Government is 0% of Total Subcontractors' costs.
  - 3) Architectural/engineering fees charged by the Lessor for Tenant Improvements are \$0.00 per ABOA.
  - 3) Architectural/Engineering fees charged by the Lessor for Tenant Improvements requested by the Government is 0% of Total Tenant Improvement Construction Costs.
  - 4) Project Management fees charged by the Lessor for Tenant Improvements requested by the Government is 0% of Total Tenant Improvement Construction Costs.

In accordance with Paragraph 3.4, "GSA Forms and Pricing Information" and Paragraph 5.1, "Tenant Improvements Pricing Requirements" of the Lease, the overhead and profit charged by the Lessor for Tenant Improvements requested by the Government is {Overhead & Profit Percentage} of Total Construction costs.

- 15. In accordance with Paragraph 4.6 "Overtime Usage", of the lease, the additional cost to the Government for overtime HVAC services is \$25.00 per hour.
- 16. In accordance with Paragraph 4.4, "Adjustment for Vacant Premises", of the lease, if the Government fails to occupy any portion of the lease premises or vacates the premises in whole or in part prior to expiration of the terms of the lease, the rental rate for the vacated portion of the space will be reduced by \$1.00 per ANSI/BOMA Office Area square foot.
