WHEREAS, the parties hereto desire to amend the above Lease.

**NOW THEREFORE**, these parties for the considerations hereinafter mentioned covenant and agree that the said lease is amended, effective upon execution by the Government, as follows:

The purpose of this Lease Amendment (LA) 5 is to provide for alterations in the above named lease space.

1. The Lessor shall provide alterations in consideration of a one-time lump sum payment not to exceed **\$8,757.14** at 1551 Mercantile Ave., NE, Albuquerque, NM. 87107-7001. Alterations shall be provided in accordance with the Scope of Work dated August 8, 2018, Exhibit A and the lessor's cost proposal attached as Exhibit B. The Scope of Work (Exhibit A) and the cost proposal (Exhibit B) are hereby incorporated into the lease.
2. Lessor will maintain all alterations. Lessor hereby waives all rights to restoration pertaining to these alterations.
3. All work will be completed within 60 calendar days, as stated in the Scope of Work. Work will be coordinated with Caleb Oldham at (817) 602-4927.
