

US GOVERNMENT LEASE FOR REAL PROPERTY

THIS LEASE, made and entered into this date by and between MILLER, GERALD R

Whose address is [REDACTED]

and whose interest in the property hereinafter described is that of **OWNER**

hereinafter called the Lessor, and the **UNITED STATES OF AMERICA**, hereinafter called the Government:

WITNESSETH: The parties hereto for the considerations hereinafter mentioned, covenant and agree as follows:

1. The Lessor hereby leases to the Government the following described premises:

A total of 3,482 rentable square feet (RSF) of office and related space, which yields 3,416 ANSI/BOMA Office Area square feet (USF) of space at the Miller Building, 627 West Broadway Street, Muskogee, OK 74401 to be used for such purposes as determined by the General Services Administration. Included in the rent at no additional cost to the Government are three surface parking spaces for exclusive use of Government employees and patrons.

2. TO HAVE AND TO HOLD the said premises with their appurtenances for the term beginning upon completion and acceptance of the work required by this lease and continuing for a period of ten (10) years, subject to termination and renewal rights as may be hereinafter set forth.

3. The Government shall pay the Lessor annual rent of \$90,667.31 at the rate of \$7,555.61 per month in arrears for years 1 - 5, which includes annual shell rent of \$48,887.28 at the rate of \$4,073.94 per month, annual operating expenses of \$16,400.22 at the rate of \$1,366.69 per month, annual amortized Tenant Improvement Allowance of \$23,572.97 at the rate of \$1,964.41, and annual amortized security costs of \$1,806.84 at the rate of \$150.57 per month.

For years 6 - 10, the Government shall pay the Lessor annual rent of \$72,634.52 at the rate of \$6,052.88 per month in arrears, which includes annual shell rent of \$56,234.30 at the rate of \$4,686.19 per month and annual operating expenses of \$16,400.22 at the rate of \$1,366.69 per month.

Rent for a lesser period shall be prorated. Rent shall be made payable to:

4. The Government may terminate this lease at any time after the fifth year by giving at least 90 days' notice in writing to the Lessor and no rental shall accrue after the effective date of termination. Said notice shall be computed commencing with the day after the date of mailing.

5. ~~This lease may be renewed at the option of the Government, for the following terms and at the following rentals:~~

~~provided notice be given in writing to the Lessor at least XX days before the end of the original lease term or any renewal term; all other terms and conditions of this lease shall remain the same during any renewal term. Said notice shall be computed commencing with the day after the date of mailing.~~

6. The Lessor shall furnish to the Government, as part of the rental consideration, the following:

A. Those facilities, services, supplies, utilities, and maintenance in accordance with SFO 5OK0012 dated September 9, 2009.

B. Build out in accordance with standards set forth in SFO 5OK0012 dated September 9, 2009, and the Government's design intent drawings. Government space plans shall be developed subsequent to award. All tenant alterations to be completed by the lease effective date identified under Paragraph 2 above. Lease term to be effective on date of occupancy, if different from the date identified in Paragraph 2.

C. Deviations to the approved design intent drawings will not be permitted unless prior written authorization is obtained from the GSA Contracting Officer.

8. In accordance with the SFO paragraph entitled *Tenant Improvement Rental Adjustment*, Tenant Improvements in the total amount of \$98,034.68 (3,416 USF x \$28.698677) shall be amortized through the rent for 5 years at the rate of 7.5%. The total annual cost of Tenant Improvements for the amortization period shall be \$23,572.97.

9. The following change was made to this Lease prior to its execution: paragraph 5 was intentionally deleted in its entirety.

10. In accordance with Subsection B(9) of the SFO paragraph entitled *Tax Adjustment*, the percentage of Government occupancy is established as 68.0%.

11. In accordance with the SFO paragraph entitled *Operating Costs*, the escalation base is established as \$4.71/RSF (\$16,400.22/annum).

12. In accordance with Subsection C of the SFO paragraph entitled *Measurement of Space*, the common area factor is established as 1.019321 (3,482 RSF/3,416 USF).

13. In accordance with the SFO paragraph entitled *Adjustment for Vacant Premises*, the adjustment is established as \$2.00/USF for vacant space (rental reduction).

14. In accordance with the SFO Paragraph entitled *Overtime Usage*, the rate for overtime usage is established as \$17.50 per hour for the entire leased space.

15. Security costs in the total amount of \$7,514.23 shall be amortized through the rent for 60 months at the rate of 7.5%.

16. The Lessor and the Broker have agreed to a cooperating lease commission of 4% of the firm term value of this lease. The total amount of the commission is \$[redacted]. The Lessor shall pay the Broker no additional commissions associated with this lease transaction. In accordance with the "Broker Commission and Commission Credit" paragraph, the Broker has agreed to forego [redacted] of the commission that it is entitled to receive in connection with this lease transaction (Commission Credit). The Commission Credit is \$[redacted]. The Lessor agrees to pay the commission less the Commission Credit to the broker in accordance with the "Broker Commission and Commission Credit" paragraph in the SFO attached to and forming a part of this lease.

Notwithstanding Paragraph 3 of this Standard Form 2, the shell rental payments due and owing under this lease shall be reduced to fully recapture this Commission Credit. The reduction in shell rent shall commence with the first month of the rental payments and continue as indicated in this schedule for adjusted Monthly Rent:

First Month's Rental Payment of \$7,555.61 minus one half of the Commission Credit (\$[redacted]) equals \$[redacted] adjusted First Month's Rent.

Second Month's Rental Payment of \$7,555.61 minus one half of the Commission Credit (\$[redacted]) equals \$[redacted] adjusted Second Month's Rent.


17. All questions pertaining to this Lease shall be referred to the Contracting Officer of the General Services Administration (GSA) or their designee. The Government occupant is not authorized to administer this lease and GSA assumes no responsibility for any cost incurred by the Lessor except as provided by the terms of this Lease or any other authorized cost in writing by the GSA Contracting Officer. The Lessor will not be reimbursed for any services not provided for in this Lease, including but not limited to repairs, changes of scope of work, alterations, and overtime services without the written authorization of a Contracting Officer. Additionally, rental will not be paid for occupancy in whole or in part except for the term specified herein.


18. Per the Debt Collection Improvement Act, effective July 27, 1996, Electronic Funds Transfer (EFT) shall be required on all existing and new lease contracts after January 1, 1998.

19. The Lessor hereby waives and forever relinquishes any right to make a claim against the Government for restoration arising from alteration or removal of any alteration by the Government during the term of this lease or any extensions, and for alterations completed by either the Government or Lessor including initial build out of the lease space and/or any subsequent modifications required during the lease period. At the Government's sole discretion, alterations that remain in the leased space after termination of the lease contract will become property of the Lessor.
