THIS AGREEMENT, made and entered into this date by and between Imperial/Aramingo Limited Partnership whose address is: 234 Closter Dock Rd., Closter, NJ 07624-2634

WHEREAS, the parties hereto desire to amend the above Lease to reimburse the Lessor for the work outlined in the Lessor's claim dated June 2, 2011.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective upon execution, as follows:

A. Lessor shall be reimbursed for all labor, materials, tools, equipment, services and all work associated with the claim filed June 2, 2011, attached and made part of this SLA, for work performed to repair an overflowing toilet and resultant damage at the leased location. The total cost of the reimbursement shall be in the amount of \$5,643.65.

If the Lessor chooses to have payments sent to an address other than the one listed above, that remittance address must be entered here:

Payment will become due within 30 days of receipt of a properly executed invoice.

All other terms and conditions of the lease shall remain in force and effect.
