NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said

Lease is amended, effective upon execution as follows

Paragraph 23 is hereby added to the Rider of the Lease:

- "23A. Lessor shall furnish all labor, materials, tools, equipment, services and associated work necessary to complete the scope of work as shown on the attached floorplans dated Oct.4, 1996 labeled as Sheets 1 through 12. Sheet 2 of 12 is dated Sept. 30, 1996.
- B. Work shall be completed within 121 calendar days following the date of Supplemental Lease Agreement (SLA) Number 5 award. For purposes of this paragraph the date of SLA award is deemed to be the date on which the Lessor receives a fully executed copy of this SLA Number 5.
- C. Upon completion of the work, lessor shall promptly notify the Contracting Officer, who shall promptly cause the same to be inspected. After inspection and acceptance by the Government, a properly executed invoice shall be forwarded to the General Services Administration, Keystone Realty Services District, Wanamaker Building, 100 Penn Square East, Philadelphia, PA 19107-3396. A proper invoice must reference the Lease and SLA numbers and describe the work completed and the amount billed. Payment will become due within 30 days of acceptance of the work by the Government and the amount billed.

All other terms and conditions of the lease shall remain in force and effect.
