This is a blended rate comprised of rates in Unit 1 and Unit 2. Unit 1 (210,582usf) rate is 8.17pusf/\$7.10prsf. Unit 2. (10,000usf) is \$8.73pusf/\$7.59prsf. CPI base for UNIT I and II if needed for future adjustments, is 182.3 All other terms and conditions of the lease shall remain in force and effect.
