WHEREAS, the parties hereto desire to amend the above Lease. to establish the effective date of the lease; to order change orders in the amount of and to outline the use of hand dryers in the public restrooms on the first and second floors.

NOW THEREFORE, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended, effective upon execution as follows:

A Paragraph 3 of the Standard Form 2 of the lease is hereby deleted and the following is substituted in lieu thereof:

"3. TO HAVE AND TO HOLD the said premises with their appurtenances for the term beginning on SEPTEMBER 12, 2013 through and including SEPTEMBER 11, 2028 subject to termination and renewal rights may be hereinafter set forth."

B. The Government agrees to make a lump-sum payment in the amount of the attached spreadsheet. The attached spreadsheet outlines change orders requested by the tenant agency that shall be provided and installed by the Lessor within 30 calendar days of execution of this agreement by the Government. Upon completion of the work, the lessor shall request an inspection. After inspection and acceptance of the change orders by the Government, the Lessor shall submit a properly executed original invoice.

All other terms and conditions of the lease shall remain in force and effect.

Payment will be due within thirty (30) days after GSA's designated billing office receives a properly executed invoice or acceptance of the work by the Government, whichever is later.

C. Paragraph 8.6 A 2 d is amended by adding the following to the end of the sentence:

"Paragraph 8.6 A 2 d: The parties agree to allow for a substitution of paper towel dispensers with **automatic hand dryers** in the men's and women's public restrooms on the first and second floors. The Lessor is responsible for supplying and maintaining these units. In the event that the units are not working, paper towels shall be provided in these restrooms."
