THIS LEASE, made and entered into this date by and between **El Trigal Plaza Associates, S.E.**

whose address is **PO Box 360372, San Juan, Puerto Rico, 00936-0372**

and whose interest in the property hereinafter described is that of Owner

hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WITNESSETH: The parties hereto for the consideration hereinafter mentioned, covenant and agree as follows:

1. The Lessor hereby leases to the Government the following described premises:

7,200 rentable square feet of office space consisting of 7,200 ANSI/BOMA office area square feet (ABOASF) comprising part of the 1st floor of the building known as the Trigal Plaza, Carr. #2 Esq. Expreso a Ciales, Manatí, Puerto Rico (the "Building"), in accordance with the attached drawings indicating the leased premises and labeled Exhibit "A" attached hereto and made a part hereof.

As part of this lease, the Lessor has included fourteen (14) surface parking spaces located on-site adjacent to the Building, all at no cost to the Government.

2. ~~TO HAVE AND TO HOLD the said premises with their appurtenances for the term beginning on~~

The Government may terminate this Lease on or after the 5<sup>th</sup> year by giving at least ninety (90) days prior notice in writing to the Lessor and no rental shall accrue after the effective date of termination. Said notice period shall be computed commencing with the day after the date of mailing.

5. ~~This lease may be renewed at the option of the Government, for the following terms and at the following rentals:~~
