Paragraph 10 of the lease is hereby deleted in its entirety and replaced as follows:

"10. The rental rate in paragraph 3 of Supplemental Lease Agreement 02 for the period of five (5) years includes all Tenant Improvements. The actual cost of the tenant improvement construction is \$860,031.00. The Tenant Improvement Allowance (TIA) in the amount of \$437,302.80 at \$32.40 per ABOASF will be amortized over a period of 60 months at an interest rate of 6.0%, at a rate of \$7.52 per ABOASF (\$6.48 per RSF). The overage in Tenant Improvement (TI) costs shall be reimbursed to the Lessor in a one-time lump sum payment in the amount of \$422,728.20 which shall be due upon receipt of an original invoice submitted after completion, inspection, and acceptance of the space by the Contracting Officer or designated Contracting Officer Representative."

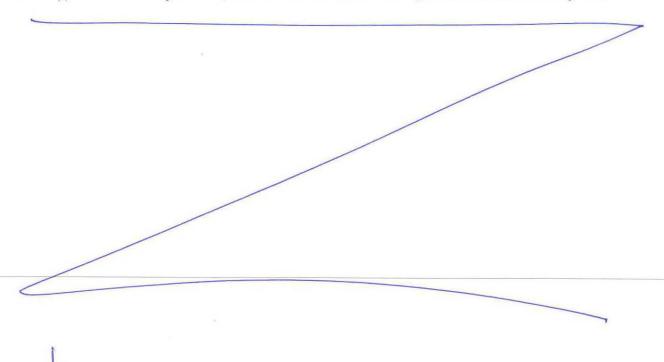
