SUPPLEMENTAL LEASE AGREEMENT

THIS AGREEMENT, made and entered into this date by and between Rooker Knoxville ODAR, LLC

hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereafter called the Government:

WHEREAS, the parties hereto desire to amend the above Lease.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that said Lease is amended, effective April 29, 2011 to issue the Notice to Proceed for the low voltage cabling installation and establish the revised T/I amount not to exceed [REDACTED]

This serves as a Notice to Proceed (NTP) for the construction of tenant improvements at 135 Circle Lane, Knoxville, TN 37919-4867.

Tenant Improvements in the amount of \$780,910.70 were approved in Supplemental Lease Agreement 2 and Tenant Improvements in the amount of \$414,632.73 were approved in Supplemental Lease Agreement 3. This Notice to Proceed revises the total T/I amount to NOT EXCEED [REDACTED] (TI Summary attached on Page 2). Lessor hereby acknowledges that under no circumstances, does this authorize the expenditure of funds beyond the amount above. Any additional expenditures made but not first authorized by a GSA Contracting Officer will be made at Lessor's risk.

Upon completion, inspection and acceptance of the space by the Contracting Officer, the Government shall reimburse the Lessor in a lump sum payment in the amount of [REDACTED] - \$780,910.70) upon receipt of an original invoice. The original invoice must be submitted directly to the GSA Finance Office online at [www.finance.gsa](http://www.finance.gsa).
