THIS AGREEMENT made and entered into this date by and between Mercantile Partners, L.P.

Hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereafter called the Government.

WHEREAS, the parties hereto desire to amend the above referenced Lease.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective January 5, 2010, as follows:

The purpose of this Supplemental Lease Agreement (SLA) is to document, approve, and accept the scope of work to be performed in accordance with Lease GS-07B-13867 for the site alterations to the [REDACTED] and payment to be made by a lump-sum payment.

Once signed by the Government, this SLA shall serve as authorization for alterations within the leased space for the [REDACTED] [REDACTED] as specified in the attached Scopes of Work and Proposals #848 and #894. The Government shall pay the Lessor a one-time lump sum payment not to exceed \$24,397.50 payable in arrears in accordance with the lease and after final acceptance by the Government for work specified in the attached documents below. The work associated with this SLA shall be billed under PS0016499.
