NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective February 12, 2010, as follows:

The purpose of this Supplemental Lease Agreement (SLA) is to incorporate the scope of work as described in Proposal #897 Revised dated February 11, 2010, and incorporated into SLA No. 43 for work to be performed on the 3rd floor in accordance with Lease GS-07B-13867 for the site alterations to the made by multiple lump-sum payments.

Scope of Work - Proposal #897 Revised dated February 11, 2010 (8 pages) is broken down as follows - Phase 1 \$345,936.80, Phase 2A \$136,635.75, Phase 2B \$144,295.88, Phase 3 \$105,824.15 is included and made part of this SLA

Once signed by the Government, this SLA shall serve as authorization for alterations to be performed within the leased space for as specified in the attached Scope of Work. The Government shall pay the Lessor at completion stages of 25%, 50%, 75% and 100% for each phase and a total lump sum payment not to exceed \$732,692.58 payable in arrears in accordance with the lease and after final acceptance by the Government for work specified in the attached documents below. The Lessor is to contact the Contracting Officer when the stages are near completion to arrange for the Project Manager to visit site, inspect and prepare the GSA Form 220. The work associated with this SLA shall be billed under PS0016727.
