## Supplemental Lease Agreement #4 GS-07B-16558

- 1) The Lessor shall provide all the materials, labor, and services required to provide the completion of the Tenant Improvements referenced as follows:
  - Change order for Kane screen in the amount of \$7432.43 of which the Lessor shall pay \$1,206.43 and the Government shall owe \$6,226.00 as depicted on the attached Exhibit "A" consisting of 2 pages.
- 2) Upon full execution and delivery of this SLA, the Lessor can consider this as a Notice to Proceed with the Tenant Improvement construction.
- 3) The Government shall pay the Lessor for the total cost of the Tenant Improvements as follows:

The Government and the Lessor have agreed that the total cost of the Tenant Improvements shall change from \$240,135.04 to \$246,361.04. The Tenant Improvement cost includes all the Lessor's fees for general and administrative costs, profit, and any and all other fees associated with the completion of the Tenant Improvements by the anticipated date of completion.

Any changes to the Construction Drawings referenced in SLA #2 which result in a financial change to the lease agreement, of any type, must be approved, in writing, by the GSA Contracting Officer.

A portion of the Tenant Improvement costs, \$65,041.20, shall be amortized over the first ten (10) year firm term of the lease agreement at an interest rate of 6 percent (%), paid monthly in arrears.

The remaining balance of the total cost of the Tenant Improvements is \$181,319.84 [\$246,361,04 - \$65,041,20] and shall be paid by a lump-sum-payment upon the substantial completion and acceptance by the Government of the tenant improvements necessary to finish the interior of the leased space. All fees, permits, and architectural plans are the responsibility of the Lessor and are included in the lump-sum-payment amount.

To submit for payment of the lump-sum-payment, the Lessor agrees that the invoice shall be printed on the same letterhead as the Lessor named on this lease, and shall include the Lease number, building address, price, and quantity of the items delivered. PS number (PS0020786) must be annotated on the invoice and the invoice shall be sent electronically to the GSA Finance Website at http://www.finance.gsa.gov/defaultexternal.asp.
