WHEREAS, the parties hereto agree to supplement the above Lease to order additional tenant improvements which exceed the tenant improvement allowance.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective April 6, 2012, as follows:

1. The Government hereby issues Notice to Proceed for additional Tenant Improvements in the amount of \$1,982.40 for materials, labor, services, and administrative costs to complete the scope of work for Change Order Request # 3, dated 03/29/12, which includes a [REDACTED] as described in Exhibit A to SLA # 5 attached hereto.
2. Upon completion, inspection, and acceptance of the space, the Government shall reimburse the Lessor in a lump sum payment in the amount of \$1,982.40, upon receipt of an original invoice after completion, inspection, and acceptance of the space by the Contracting Officer.
