WHEREAS, the parties hereto desire to amend the above Lease.




- 1.) To provide a Notice to Proceed for Change Order (C/O) Proposal #1 and provide for an anticipated date of completion; and

- 3.) To provide for the method of payment of the Tenant Improvements and BSS; and
- 4.) All other terms and conditions of the lease shall remain in full force and effect.

- 1) Upon this Lease Amendment (LA) being fully executed and delivered, the Lessor shall consider this a Notice to Proceed on the alterations required in Change Order C/O Proposal #1 for (Additional Work Requested for Consideration) dated November 16, 2012 as it relates to security changes, HVAC rebalancing and fencing for parking lot; all of which are depicted in Exhibit "A." The total cost of the C/O Proposal #1 is [REDACTED]. The anticipated date of completion of all the Tenant Improvements (TI) and Building Specific Security (BSS) is March 12, 2013.
- 2) The Government and the Lessor have agreed that the total cost of the TI and BSS shall change from [REDACTED] to ~~\$169,690.31~~ [REDACTED] = \$169,690.31]. The TI and BSS cost includes all the Lessor's fees for general and administrative costs, profit and any and all other fees associated with the completion of the TI and BSS costs covered by C/O Proposal #1 by the anticipated date of completion.
- 3) It is mutually agreed to by the Government and the Lessor that the total TI and BSS cost is \$169,690.31. And shall be paid to the Lessor in a Lump - Sum Payment upon completion and acceptance of the premise by the Government.

Upon the completion of the TI and BSS and the acceptance thereof by the Government, the rent commencement date shall be established by a separate LA. The subsequent LA shall include the term of the scheduled total rent, the annual Shell Rent amount, the annual Operating Cost amount.

To submit for payment of the lump-sum payment in the exact amount of \$169,690.31, the Lessor agrees that the invoice shall be printed on the same letterhead as the named on this lease, shall include the Lease number, building address, and a price and quantity of the items delivered. **The invoice shall reference the number PS0024514** and shall be sent electronically to the GSA Finance Website at <http://www.finance.gsa.gov/defaultexternal.asp> .
