Open Office 1-6 East and West (Open Office 403) - Attached are sketches indicating where the outlets should located in the two Open Office areas (East and West). Each workstation needs its own outlet rather than sharing one per 2-pack.

Office 23-26A (Room 409) - The desk/credenza will be moved away from the north wall to allow for the 9" column. Relocate the current outlet combination to correspond with the furniture opening shown on the attached sketches based on the movement of the furniture.
