<p>Scope: This is an administrative change to provide the PD Number (PDN) for PCOs 110 and 146. The settled amounts of PCOs 110 and 146 remain unchanged. This SLA removes PCO 110 and PCO 146 from SLA 13 and SLA 12, respectively, and reissues PCOs 110 and 146 with a PDN as SLA 16.</p> <p>In SLA 12, delete the dollar amount of \$4,684 shown for PCO 146 and annotate SLA 12/PCO 146 with the words "See SLA 16"</p> <p>In SLA 13, delete the dollar amount of \$67,443 shown for PCO 110 and annotate SLA 13/PCO 110 with the words "See SLA 16"</p> <p>The combined dollar amount of \$72,127 for PCOs 110 and 146 is not payable through SLAs 12 and 13, nor was it included in the rent calculations established in SLA 14.</p>
